

## **Town of Lima - Request for Bids for Selective Timber Harvesting February, 2025**

The Town of Lima, Livingston County, New York is requesting formal written bids from parties interested in selectively harvesting certain standing timber located at the College Street Cemetery, located at and known as 7220 College Street, Lima, NY 14485 and also identified as Tax Map Parcel Number 37.9-1-50, as set forth below:

18 Black Walnut trees;  
11 Black Locust trees;  
1 sugar maple; and  
6 more trees to cull

ALL TREES TO BE HARVESTED ARE MARKED IN BLUE

The responsible bid will provide a lump-sum purchase price for harvesting and removal of marked trees/standing timber, with tops being neatly piled and left on site.

The responsible bid shall provide for the vendor being responsible for and providing clean-up, restoration and repair to all damaged headstones, grass/ lawn areas and any roadway, driveway or path used or damaged in the process of removal of such trees/standing timber.

The responsible bid shall provide that removal of the marked trees/standing timber shall be completed within sixty (60) days of the award by the Town to the successful bidder.

The responsible bid shall provide shall provide for the vendor being responsible for and providing clean-up, restoration and repair to all grass/ lawn areas and any roadway, driveway or path used in the process of removal of such trees/standing timber, to be completed within seventy-five (75) days of the award by the Town to the successful bidder.

1. All bids shall be in writing and shall state the bid price in United States Dollars;

2. All written bids shall be returnable to the Town of Lima, Attention: Town Clerk at 7329 East Main Street, Lima, New York 14485 and shall be post marked or delivered no later than March 3, 2025 at 4:00 p.m.;
3. All bidders must provide proof of insurance with bid for general liability coverage of not less than \$1,000,000 each occurrence, \$2,000,000 general aggregate and \$1,000,000 excess liability each occurrence;
4. All bidders must provide proof of insurance with bid for statutory worker's compensation and disability insurance;
5. All proposals shall be fully compliant with all federal, state and local codes, rules and regulations;
6. Bids will be opened on March 4, 2025 at 6:30 p.m.
7. The Town of Lima reserves the right to reject any and all bids.
