Official Minutes

An official meeting of the Town Board of the Town of Lima, County of Livingston and the State of New York was held at the Town Hall, 7329 East Main Street, Lima, New York, on the 5th day of September 2023 at 6:00 P.M. Notice was printed in the Mendon-Honeoye Falls-Lima Sentinel.

Supervisor Falk called the meeting to order and led in the Pledge of Allegiance.

Approval of the Agenda

Supervisor Falk asked for a motion to approve the agenda. Upon motion by Councilperson Carey to approve the agenda as distributed, seconded by Councilperson Torpey, the vote was unanimous.

Town Board Meeting Protocols

Supervisor Falk read Town Board meeting protocols as follows:

"The Town of Lima follows NYS Open Meetings Law procedures. All meetings of the Town Board are duly noticed and open and accessible to the public. The public is there to witness the proceedings only. In the event of a Public Hearing, people may sign in and speak to the board and those assembled regarding the hearing topic for a maximum of 5 minutes once per board meeting. Speaking time belongs only to the speaker and may not be reassigned to someone else. Privileges of the floor may be granted to anyone who wishes to address the board on any topic at all. In order for the public to be properly noticed the Privileges of the Floor must be applied for and approved by five calendar days prior to the Board meeting date. Privileges of the floor are not to exceed 20 min. Approval authority for privileges of the

floor is held by the Supervisor or the Deputy Supervisor if the Supervisor is unavailable. At the beginning of each meeting the public may sign up to speak for 5 minutes on any posted agenda topic. Questions can be answered during the agenda discussion or logged for answer after research. At the very end of each meeting the public may sign up to speak for 5 minutes on any topic at all. Questions can be answered or researched and answered later."

Fire Protection & Ambulance Protection Agreements

Supervisor Falk spoke with Mayor Skiptunas regarding the increase in fees for both agreements. Tax Cap

Town Attorney Campbell distributed a proposed local law to override the tax levy limit established in General Municipal Law 3-C. BBS Contract for Bookkeeping and Payroll Services

After discussion and upon motion by Councilperson Petroski to accept the contract covering services through December 31, 2024, in the amount of \$19,800, seconded by Councilperson Carey, the vote went as follows:

Excellus Health and Dental Insurances

After discussion and upon motion by Councilperson Petroski to adopt the same plans as employees had last year, seconded by Councilperson Carey, the vote was unanimous. (12.09% increase for health and 9.07% increase for dental)

Community Fitness and Health Proposal

Erika Reinhardt-Roggow, RN, MS, CPT of Embrace Fitness and Health submitted a proposal for consultation of \$300 per month from the Town/Village of Lima for coordinate, research and either implement or recruit a qualified individual to conduct a monthly fitness and health program for residents. After discussion and upon motion by Councilperson Petroski, it was agreed to table this item until further discussion is had with Mayor Skiptunas, seconded by Councilperson Torpey, the vote was unanimous.

First Net

CARRIED

Discussion was held to establish an account with First Net via AT&T. This service provides essential workers to a line solely dedicated for first responders and those on call for a reduced rate. Upon motion by Councilperson Petroski to set up an account for the Town of Lima, seconded by Councilperson Carey, the vote was unanimous.

Close Public Hearing - A proposed Local Law # 3 of 2023 to Establish a Real Property Tax Exemption for Certain Qualifying Volunteer Firefighters and Volunteer Ambulance Workers

Attorney Campbell notified the Board that the proposed Local Law constitutes a Type 2 Action under SEQR and that accordingly, no further SEQR review is necessary for the Board to take action. Upon motion by Councilperson Petroski to close the public hearing at 7:32PM and approve same, after no discussion, seconded by Councilperson Carey, the vote went as follows:

TOWN OF LIMA LOCAL LAW NO. 3 of 2023

LOCAL LAW NO. 3 PROVIDING A PARTIAL EXEMPTION FROM REAL PROPERTY TAXES TO CERTAIN ELIGIBLE VOLUNTEER FIREFIGHTERS AND VOLUNTEER AMBULANCE WORKERS

Be it enacted by the Town Board of the Town of Lima as follows:

Section 1. The intent of this Local Law is to adopt a real property tax exemption pursuant to New York State Real Property Tax Law 5466-a, for certain qualifying volunteer firefighters and volunteer ambulance workers that are residents of the Town of Village of Lima, Livingston County, New York.

Section 2. Real property owned by an enrolled member of an incorporated volunteer fire company, fire department, or incorporated volunteer ambulance service, residing in the Town or Village of Lima, Livingston County New York, shall be exempt from taxation to

the extent of 10% of the assessed valuation of the qualifying person's Primary Residence (As defined below) for Town purposes, provided the owner(s) meet the qualifications set forth in section 3 below.

Section 3. To be eligible for the exemption authorized by Real Property Tax Law \466-a and implemented by this Local Law, the subject real property must be owned by an enrolled member of an incorporated volunteer fire company, fire department, or incorporated volunteer ambulance service residing in the Town or Village of Lima, Livingston County, New York, subject to the following additional requirements: (a) the enrolled member resides in the Town or Village of Lima; (b) the real property for which the exemption is sought is used as the Primary Residence of the enrolled member; (c) the real property for which the exemption is sought is used exclusively for residential purposes; provided however, that in the event any portion of such property is not used exclusively for the enrolled member's Primary Residence, but is used for other purposes, such portion shall be subject to taxation at the full taxable rate and the remaining portion, only, shall be entitled to the exemption provided by this Local Law; and (d) the enrolled member has been certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department or incorporated volunteer ambulance service as an enrolled member of such incorporated volunteer fire company, fire department or incorporated volunteer ambulance service for at least two (2) years prior to the date of application for the exemption established hereby.

A. For purposes of this Local Law, "Primary Residence" shall be defined as the dwelling that the eligible person lives in for at least six (6) months and one day of each year for which an exemption is to be claimed.

Section 4. Any enrolled member of an incorporated volunteer fire company, fire department or incorporated volunteer ambulance service residing in the Town or Village of Lima, Livingston County, New York, who accrues more than twenty (20) years of active service and is so certified by the authority having jurisdiction for the incorporated volunteer fire company, lire department or incorporated volunteer ambulance service, who also meets all of the requirements set forth in Section 3, shall be granted a 10% exemption as described above for the remainder of his or her life as long as his or her Primary Residence is located within the Town or Village of Lima.

Section 5. An un-remarried spouse of a volunteer firefighter or volunteer ambulance worker killed in the line of duty while an enrolled member of an incorporated volunteer fire company, fire department or incorporated volunteer ambulance, serving the Town of Lima, shall be eligible to receive the 10% exemption as described above provided that (a) such un-remarried spouse is certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department, or incorporated volunteer ambulance service as an un-remarried spouse of an enrolled member killed in the line of duty; (b) such deceased volunteer had been an enrolled member for at least five (5) years; and (c) such deceased volunteer had been receiving the exemption permitted hereby prior to his or her death.

Section 6. An un-remarried spouse of a deceased volunteer firefighter or volunteer ambulance worker shall be eligible to receive the 10% exemption as described above provided that: (a) such unremarried spouse is certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department, or incorporated volunteer ambulance service as an un-remarried spouse of a deceased enrolled member; and (b) such deceased

volunteer had been an enrolled member of an incorporated volunteer fire company, fire department or incorporated volunteer ambulance, serving the Town of Lima, for at least twenty (20) years, and (c) such deceased volunteer had been receiving the exemption prior to his/her death.

Section 7. The Local Law shall take effect immediately upon its filing in the Office of the Secretary of State.
